



RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT (THE “AGREEMENT”)

IN CONSIDERATION of my participation with RVRD LLC (the “Production”) I, for myself for personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of the dangers of (the “Production”) and have been briefed on the safety procedures involved. This does not guaranty my personal safety or property damages. If I do not agree to release all and an liabilities from RVRD LCC, I will immediately discontinue further participation in the activity.

2. FULLY UNDERSTAND THAT: (a)THE ACTIVITY INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY (the “Risks”); (b) these Risks and dangers may be caused by my own actions or inaction’s, the actions or inaction’s of others participating in the Activity and/or the condition in which the Activity takes place; (c) there may be other Risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, DAMAGES, LIABILITIES AND PROPERTIES I incur as a result of my participation in the Activity.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE RVRD LCC and/or related production company(s), its administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owner and lessors of premises on which the Activity takes place, (the “Released Parties”) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES FOR DEATH, PERSONAL INJURY OR PROPERTY DAMAGE OF ANY KIND OR NATURE what so ever arising out of, or in the course of, my participation in the Activity. I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Released Parties, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASED PARTIES from any litigation expenses, attorney fees, loss, liability, damage, or cost which they may incur as the result of such claim.

ACKNOWLEDGE, agree, and represent that I understand RVRD LLC, is not responsible for loss or damage to my personal possessions and that my photograph or video may be used in future promotions. **I have read this agreement, fully understand its terms, understand that i have given up substantial rights by signing it and have signed it freely and without inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.**
